

Y-Wives 2019 Holiday Extravaganza

Dear Crafters and Tiffin Area Merchants:

Our annual Holiday Extravaganza will be held on November 9th, 2019 from 10:00 a.m. to 4:00 p.m. at the Tiffin Community YMCA. Direct sales product vendors will be taken on a first come basis by postmark date and time, and only one from each company. The booths will be located in the fieldhouse, conference room, and childcare room. Participants will be responsible for their own tables, chairs, (you may rent tables and chairs) extension cords, displays, and setup and take-down. Space rental will be \$50.00 for the first booth and \$25.00 for each additional booth, there will be an additional \$5.00 charge for electricity. Most booths are 10 x 10 feet. There is no limit to the number of booths you may rent. Booth spaces are on a first come first serve basis. **Only booths rented on the day of the 2019 Extravaganza will have the option of reserving the same booth. After the 2019 show booths will be rented based on availability, and we will not guarantee spots held the previous year.**

The YMCA will provide electricity for a \$5.00 fee paid at the time of the registration. Electricity is VERY limited, as many of the vendors renew their spots for the next year. Any requests for electricity will be taken on a first response basis, by postmark date and time. We ask that you only order electricity if really needed, because of the extreme limitations of available spots. We have tables and chairs available to rent for the day. Tables of 8-foot length are \$10.00 each and chairs are \$2.00 each. Please order them at the time you are sending in your application, as we have to rent them and need an accurate count when ordering.

Limited free babysitting will be available on a first come basis (2 hours maximum) and a delicious hot lunch is served to the public at a nominal fee. We will be offering a bag lunch to the vendors at a cost of \$5.00. We will have volunteers delivering these lunches to your booth.

For those of you wishing to set up early, the YMCA gym will be open from 12:00 p.m. until 8:00 p.m. on Friday, November 9th, and 7:00 a.m. on Saturday. Entrance will be through the garage, walkway outside of pool, and front of building only. All cars must be moved immediately after your items are unloaded. Failure to do so may result in vehicles being towed at the owner's expense. We have 115 vendors trying to move their items in so please be courteous.

We do not allow the burning of candles. Because so many vendors now sell candles, it is a safety issue, and we have guests with allergies. We are sorry for any inconvenience.

Y-Wives Holiday Extravaganza

1. Exhibitors are responsible for following all state and local laws, including the charging of sales tax.

3. Although the building will be secured at night, exhibitors are responsible for their merchandise. Neither the promoters nor the YMCA will be responsible for fire, theft, damages, or any injuries incurred.
4. In the extreme circumstances the show must be canceled, the exhibitor shall promptly receive all money paid and waives any other claims or damages.
5. Exhibitors are required to notify the promoters in case of cancellation. **Booth cancellations up to four weeks prior to the show, are subject to a \$10.00 per booth processing charge. After that time, no refunds will be made. Cancellation of requested tables must be made four weeks prior to the show or no refund will be given.**
6. **Please specify your type of crafts or goods.** Note: We reserve the right to decline applications that we feel may be detrimental to the show. We only allow one of each type franchise merchandise.
7. **No spaces will be held without payment.** Booths will be reserved on a first come first serve basis.
8. **In signing this application, the exhibitor understands and agrees to the above regulations, if accepted into the show.**
